A wide definition of "donation" is set out in s.22 of the Electoral Act 1997 (as amended by s.49 Electoral (Amendment Act) 2001 and s7 Electoral (Amendment)(Political Funding) Act 2012) and s.46 Electoral Act 1997 and includes, **in addition to donations of money**, services supplied without charge, a donation of property or goods or the free use of same.
