Introduction

The Registry of Friendly Societies (RFS) is a statutory office of the Department of Enterprise Tourism and Employment.

The RFS deals with three different entity types, namely industrial and provident societies which in the main consist of co-operatives, friendly societies, and trade unions which include employee unions, employer associations and trade associations.

The principal legislation governing these entities is:

- Industrial and Provident Societies Acts, 1893 2021.
- Friendly Societies Acts, 1896 2021
- Trade Union Acts, 1871 1990.

Statement of Strategy

The Mission Statement of the Registry of Friendly Societies is:

"To ensure that the various mutual entities registered at the Registry, which are subject to general regulation and supervision in varying degrees by the Registrar of Friendly Societies, comply with their statutory obligations and to maintain an up-to-date public record on those entities".

This mission statement is accomplished through two core objectives, namely:

- The efficient and effective registration and general regulation of industrial and provident societies, friendly societies, and trade unions.
- The provision of an efficient and effective service to the public.

2024 Overview

At the end of 2024 there were 964 industrial and provident societies, 46 friendly societies and 46 trade unions on the register, making a combined total of 1,056 registered entities. As such, 2024 saw a decrease of 2 in the number of societies/trade unions on the register compared to the end of 2023.

The chart below shows the ratio of industrial and provident societies, friendly societies, and trade unions on the register at 31 December 2024.



Fig. 1: Ratio of I&P Societies, Friendly Societies and Trade Unions at end 2024

Details of the various registrations completed during 2024 are set out in the following pages of this report.

There are additional matters which a registered society or trade union must register or record in addition to sending annual returns and accounts to the Registrar, and these matters include:

- partial and complete rule amendments/alterations,
- changes of name and registered office,
- special resolutions.

Details of each of the above matters are also included in this report.

The RFS customer service targets regarding processing applications and making documents available to the public range from five to ten working days in respect of correctly completed applications and are dependent on the nature of the application involved. These targets were achieved during 2024.

From time to time the RFS carries out targeted enforcement campaigns aimed at identifying societies and unions overdue in their annual return filing obligations, seeking their compliance in coming up to date on the register and, where this cannot be achieved, ultimately cancelling the registration of those entities, and removing them from the register The reminder campaign in 2024 resulted in the majority of societies bringing their filings up to date. The RFS

continues to monitor compliance with a view to encouraging all societies to file on a timely basis, and where necessary will initiate further targeted compliance and enforcement drives.

Important note on the submission of annual returns

Accounts for societies are required to be audited in accordance with the relevant legislation i.e. the Industrial and Provident Societies Acts 1893 to 2021 or the Friendly Societies Acts 1896 to 2021.

A significant number of accounts submitted to the RFS contain references to companies and to the Companies Act. Where accounts submitted, whether in the auditor's report or the officer's statements, refer to the entity as a company or to the Companies Act, the submission will be rejected and returned to the presenter for correction.

The auditor's report should refer to the appropriate legislation for the entity concerned.

References to entity types should be to an industrial and provident society or a friendly society as appropriate.

Forms and audited accounts must be wet signed original signatures of the statutory auditor and the committee of management. There is no provision under the Industrial and Provident Societies Acts 1893 to 2021 or the Friendly Societies Acts 1896 to 2021 for type signed or other type signatures.

Only the registered name of the entity as it appears on the public register should be used on the forms and the accounts. The registered name should not be abbreviated. The Industrial and Provident Societies Acts 1893-2021 do not provide for the use of abbreviations of "Limited" or "Teoranta".

Audited Accounts for Trade Unions should reference the Trade Union Acts 1871-1990 and should have wet signed original signatures of officers and auditor. Only registered rules should be attached to the annual return form with the signed audited accounts.

Requests to the Registrar for approval for specific words in a company or business name

If a company or business wishes to use words: Society, Union, Co-Operative or variations of these words in their registered name they must obtain permission from the Registrar of Friendly Societies.

The RFS now has its own website at <u>Home - RFS</u>. General information and prescribed forms pertaining to industrial and provident societies, friendly societies, and trade unions are available here.

Statutorily filed RFS documents pertaining to all RFS entities filed from 2010 onwards, including annual returns, are available on-line via the CRO CORE online portal that can now be reached at CORE (cro.ie) Payments are made by Credit/Debit card or CRO customer account. Access to the online portal allows members of the public to view and check the status of all registered entities and purchase registered documents.

The RFS engaged throughout the year with stakeholders and the Department of Enterprise Tourism and Employment in relation to matters of common interest and issues of policy concerning societies and trade unions.

The Companies (Miscellaneous Provisions) (Covid-19) Act 2020 came into effect in August 2020 and made temporary amendments to the Companies Act 2014 and the Industrial and Provident Societies Act 1893 to address Covid-19 related issues. The Act provided for the holding of Annual General Meetings and general meetings by electronic means. It also made provision in respect of business solvency by extending the period of examinership and increasing the threshold at which a company is deemed unable to pay its debts. The temporary amendments to the Industrial and Provident 1893 continued until end 2024 with the statutory instrument: S.I. No. 647/2023 - Industrial and Provident Societies Act 1893 (Section 14A(1)) (Covid-19) Order 2023. On 3rd December 2024, the Companies (Corporate Governance, Enforcement and Regulatory Provisions) Act 2024 provided for the conduct of, and participation in, general meetings of an industrial and provident society by the use of electronic communications technology on a permanent basis.

Industrial and Provident Societies

During the year under review the RFS registered 7 new societies (includes 2 on conversion from companies)

No society was restored to the register by High or Circuit Court Order in 2024

A number of existing societies amended their rules either partially or completely during the year.

A total of 9 societies were cancelled and were removed from the register, 1 on completion of liquidation, 5 at their own request, 3 societies on conversion to companies.

Following cancellation societies lose all privileges granted under the Industrial and Provident Societies Acts 1893-2021 which includes the loss of limited liability.

Friendly Societies

Since the enactment of the Friendly Societies and Industrial & Provident Societies (Miscellaneous Provisions) Act 2014 it is no longer possible to register a new friendly society.

No society was restored to the register in 2024.

4 societies had a partial amendment to rules registered during the year.

No society had a complete amendment to rules registered during 2024.

No society was cancelled at its own request.

Trade Unions

1 new trade union was registered in 2024.

No trade union had its registration cancelled at its own request.

7 trade unions had partial alteration of rules registered during the year.

5 trade unions had complete alteration of rules registered during the year.

No trade union was cancelled following dissolution.

Registry of Friendly Societies staff

At the end of 2024, the RFS had a staffing complement of 5, (including the Registrar and Assistant Registrar) with certain staffing positions including the Registrar also having responsibilities and core functions in the CRO and RBO.

Overview of Energy – S. I. 542 of 2009

S.I. 542 of 2009 requires public sector organisations to report annually on their energy usage and actions taken to reduce consumption.

Overview of Energy Usage 2024

The Registry of Friendly Societies (RFS) is in Bloom House Gloucester Place Lower, Dublin 1 and shares accommodation and many administration services, including energy consumption, with the Companies Registration Office.

The RFS shares the building with CRO along with meeting rooms, toilets and the reception area with the Competition and Consumer Protection Commission (CCPC) as well as private firms.

Bloom House has a Building Energy Rating of B3. BER No.: 800191413. Energy Performance Indicator: 77.12kg CO2 /m2 /yr.

Obligations under sections 4B(a) and 4B(b) of the consolidated Official Languages Act 2003 and 2021

The RFS is committed to meeting all its obligations under the Official Language Acts (2003 & 2021).

A member of the RFS has been appointed to oversee performance and report on the RFS's obligations under the Official Languages Acts (2003 & 2021).

The following actions were taken by the RFS during the year 2023 to ensure compliance with the Act:

• review of RFS website to ensure the Irish version was available and correct

During 2023 the new obligations under section 10A. (Advertising by Public Bodies) requiring a minimum of 20% (10A. (1)(b)) of all advertising undertaken to be in the Irish language was met. There is also an obligation of 5% of annual advertising spend on Irish language media as also prescribed under section 10A. (1)(b).

• The RFS did not engage in any advertising in 2024.

Statement on the Duty to Equality and Human Rights in the Public Sector

The Registrar draws the attention of societies to the following provisions, which relate to deposit taking by industrial and provident societies, which apply from December 2020 and which the Registrar will take note of in relation to the registration of rules. All applications to register new Industrial and Provident Societies and all requests for changes of rules must include in the rulebook that they will not receive money on deposit from members and others.

Registration

The number of newly registered industrial and provident societies in 2024 amounted to 7. (This figure includes 2 societies who converted from companies to industrial and provident societies).

No society was restored to the register in 2024.

9 societies were cancelled, 1 on completion of liquidation, 5 at their own request, 3 societies converted to companies in 2024 and were removed from the register.



Prohibition on Raising of funds

The Friendly Societies and Industrial and Provident Societies (Miscellaneous Provisions) Act 2014 amended the Industrial and Provident Societies (Amendment) Act, 1978. Certain types of industrial and provident societies are not allowed to raise funds (otherwise than by way of subscriptions for shares where the aggregate sum being raised does not exceed €30,000 in any six-month period) except under and in accordance with the written permission of the Registrar. The Registrar cannot give such permission unless she is satisfied that it is in the interests of the public or creditors of a society or of the orderly and proper regulation of the business of the society to do so. Such permission is not required in the case of a loan made to a society by a bank or to the acceptance by a registered society of any monies advanced by a public body.

During 2024 the Registrar gave permission under Section 6 of the Industrial and Provident Societies (Amendment) Act, 1978 in four cases:
